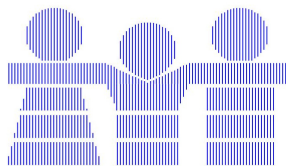

In consideration of your accepting this entry form, I being a participant in the Run For The Kids 10K, 5K or Kids 1K ("Event") therefore accept all the following waiver conditions on behalf of myself, intending to be legally bound for myself, my heirs, and administrators, and waive and release any and all rights and claims for damages I may have against the officials and sponsors of the Event, and their respective successors, and assigns, (collectively, the "Released Parties") for any and all injuries suffered by me, in this event. I agree to **indemnify, defend and hold harmless** the Released Parties from any and all claims, causes of action, damages, losses (economic and non-economic), and liabilities of every kind (collectively "Claims"), including but not limited to expenses incurred, attorney's fees and litigation expenses, arising out of or resulting from, directly or indirectly, in whole or in part, (i) my breach or failure to abide by any part of this Waiver Agreement (ii) and/or my actions or inactions which cause injury or damage to any other person and/or (iii) the death, personal injury, or property damage,

which may arise out of, result from, or relate to my participation in, or my traveling to or from the Event, including but not limited to any Claims for theft, damage to any equipment, negligence, partial or permanent disability, Claims relating to the provision of first aid, medical care, medical treatment, or medical decisions (at the Event site or elsewhere), and any Claims for medical or hospital expenses.

I acknowledge that I am aware of the inherent risks of participating in an athletic event of this type. I understand that I will be participating in the Event at my own risk, that I am responsible for the risk of participation in the event, and that I am waiving and releasing my legal rights to sue for any injury or damages arising out of or resulting from my participation in the Event. I further understand that any injury or damages incurred maybe the result of negligence, omission, or carelessness of the Released Parties; I attest I am physically fit and have sufficiently trained for the completion of this event and my physical condition has been verified by a licensed medical doctor. Further, I grant full permission to any and all of the forgoing to use photographs, videotapes, motion pictures, and recordings of me or any other record of this event for any legitimate purpose. No refunds of entry fee. I COVENANT AND AGREE NOT TO SUE any of the Released Parties for any Claims that I have waived, released, or discharge herein.

If any provision of this Waiver Agreement shall be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from the Waiver Agreement and shall not affect the validity and enforceability of any remaining provisions.
